As recommended by you and auctioning committee vide your letter under reference, the highest bid of Rs. _____ (Rupees _____ only) for a period of three year (_____) with effect from the date of approval to 31st August _____, for the Fishing Rights of _____ offered by **Mr:** _____ CNIC No: _____ resident of _____, is hereby approved in his favour as per provision of section -6 of Fisheries & Aquaculture Act 2022 the Khyber Pakhtunkhwa Fisheries Rules 1976 and S.No. 1.2 Fisheries Wing S.No.1 (i) of 3rd Schedule (Special Powers to Certain Departments) of the Delegation of Powers Rules 2018, subject to the fulfilment of the following conditions.

1. The leasee shall execute a lease deed on judicial **Stamp paper duly attested by Oath Commissioner** as required under Rules-17 and 20 (3) of Khyber Pakhtunkhwa, Fisheries Rules 1976 with in a week time from the date of approval of the auction.
2. The Assistant Director Fisheries _____ has been deposited 1/3rd of the total bid amounting to Rs. _____ /- (Rupes _____ only) under proper Government Revenue Head as already recovered from the above named highest bidder and the remaining amount of lease money for the year _____ may also be recovered in one installment for each, as per agreement of terms & conditions signed by the highest bidder.
3. Out of the total bid period (_____), Fishing Rights in the said Dam is sanctioned for one year i.e _____ with effect from the date of approval to 31st August _____, while sanction for the remaining two years will be granted each year on depositing the share of lease amount for that year. For that purpose, the lessee shall produce a bank guarantee or CDR, equal to one third of the lease amount to the satisfaction of the auctioning authority as per rules 20 of Khyber Pakhtunkhwa, Fisheries Rules 1976.
4. In case the lessee fails to pay the remaining amount within 15-days for the subsequent year _____, on or before of the due date, he will be liable to pay interest @ of 2% per annum on the due amount as per the Khyber Pakhtunkhwa Fisheries & Aquaculture Act, 2022 chapter III, Rules 5, sub rules (2).

5. In case, the lessee fails to clear the Government dues within thirty days after becoming dues for the subsequent years i.e _____, the Assistant Director Fisheries _____ is hereby authorized to initiate action against the lessee on behalf of the undersigned as per Fisheries Rules 1976, clauses (5) of rule 20 (Part-III-lessee) as amendments, 2019 and Khyber Pakhtunkhwa Fisheries & Aquaculture Act 2022, sub-section-3 of Section-6.
6. The lessee shall deposit all applicable taxes & advance income tax each year as per income tax rules, 2001 and its further amendments.
7. Fishing License and permit book may be issued on Annual basis if required after fulfillment of all codal formalities.
8. The lessee is bound to obey all the Departmental regulations and relevant terms and conditions agreed by him.
9. In case of non-compliance of any of above clauses or rules, the lessee will be proceeded against under the rules.
